## **Pollack Law Group helps provide “basic needs” for homeless families**

**SOUTHBOROUGH, MA** – When attorneys and other employees of Pollack Law Group, P.C., learned that more than 40 homeless families staying in a nearby hotel were in desperate need of personal supplies, they responded by donating dozens of bottles of shampoo, bars of soap, tubes of toothpaste and other personal hygiene items.

“These are basic necessities that most of us take for granted, but they’re a precious commodity to homeless families with limited resources,” said Attorney Irwin Pollack, founder and president of Pollack Law Group, P.C. “We hope these toiletries and other personal care items will help ease some of the burden for these families, especially given the many challenges they face.”

Barbara Jandrue, director of the United Parishes of Southborough Inc. Food Pantry, said more than 40 homeless families from throughout Central Massachusetts have been housed at the Best Western hotel in Marlborough this winter because there is no room in local shelters.

Since the families have such limited resources, local churches and other community groups have been trying to help by providing home-cooked meals and other food, Jandrue said. She also reached out to Pollack Law Group, to see if the firm could help provide basic toiletries and other personal items which are not covered by food stamps and other financial aid.

Senior Attorney Diana Sladen spearheaded PLG’s efforts, collecting more than \$250 in donations that were used to purchase dozens of items requested by Jandrue.

“This is amazing,” Jandrue exclaimed, as she loaded her car with bags and boxes overflowing shampoo, soap, toothpaste and sanitary products. “Most of these families can’t afford a family-sized bottle of shampoo or a full-sized tube of toothpaste, so they’re going to be incredibly appreciative.”

“We’re happy to be able to help fulfill such a very basic need,” said Managing Attorney David Callahan. “Our hearts go out to these families. We’re glad we can help them in some small way.”
