Re: Taxpayer/Voter Demand for Independent Counsel for Planning Board

Dear Mr. Shea,

Attached please find a taxpayer / voter petition urging in the strongest terms possible that the BOS reconsider the matter of independent legal counsel for Planning Board in support in ongoing litigation associated with all matters pertaining to Park Central.

Last week, Capital Group filed an appeal of the Planning Board site plan denial. This causes yet another factor in the ongoing challenges faced by Planning Board, an elected town board.

We do not believe that you, as Selectmen, have acted in our Town's best interest in this matter and that you have unjustly denied the Planning Board the necessary legal counsel to enable them to do the professional and appropriate job we the citizens of Southborough elected them to do. Imagine trying to function in your role without legal advice. By denying Planning Board counsel, you are inappropriately influencing their function as an elected board.

We, the taxpayers of Southborough, call upon you, our elected members of the Board of Selectmen, to authorize and provide funds for the Planning Board to hire independent legal counsel to allow them to handle all matters related to the Park Central Project in a timely and professional manner.

We are aware that actions taken by the Planning Board against the ZBA have resulted in pending litigation against the Town of Southborough. We believe that this fact is an **additional, compelling reason for the Town to provide legal counsel for the Planning Board**, and that it should not be used as a justification for denial of the Planning Board's request for legal counsel. Please note that:

- **This entire situation is completely backwards and ridiculous, caused in part by your support of the wrong board** – an appointed Board by BOS, the ZBA, versus an elected Board, Planning Board.
- **ZBA HAS ISSUED A USE VARIANCE BEFORE SITE PLAN REVIEW!**
- **The Use Variance may well have expired and is an empty, terrible business deal for the Town of Southborough, all done by the ZBA under the guidance of Town Counsel.**
- **Of the three person ZBA board, one member resigned and moved the same day as the filing of the decision! Further, your allowing the former Chair to stay on the Board has tainted the process and has allowed the entire matter to be open to question.**

The ZBA, along with your support of the wrong board and your failure to act in the best interest of the taxpayers, has actually contributed to this nonsensical situation and litigation. **THE WRONG BOARD IS GETTING LEGAL SUPPORT FROM THE TOWN.**

The failure of BOS to support an elected board over the ZBA (BOS appointed board) has contributed to the egregious actions of this rogue and out-of-control board. **The ZBA has hurt this town. No one seems to be accountable.**

Now that this is a legal process, you should not be able to manipulate the outcome by unjustly denying Planning Board appropriate legal counsel.

We do not believe that the ZBA should be the only Board that is allowed counsel. Importantly, the ZBA's actions, while under Town Counsel guidance, were egregious and did not represent this Town's best interests.

The undersigned voter / taxpayers are strongly and urgently requesting that you, the Board of Selectmen, allow the Planning Board to retain independent legal counsel—effective immediately.

Your timely and immediate response is appreciated. If this request is not handled in a timely fashion as requested, further action will be taken.
